#### RULES GOVERNING CONDUCT

3. ALL SCHOOL RULES MUST BE FOLLOWED while at a PVHS sponsored activity. Guests follow under the jurisdiction of PVHS rules and instructions given by authorized personnel at the event.
4. The guest must present valid photo ID (Student ID, Drivers License or California ID Card) at the door of the event or they will not be allowed to enter.
5. Like all PVHS students, the guest agrees to refrain from the use of alcohol and other drugs before and during the event. (A breathalyzer will be present and used at this event).

## PALOS VERDES HIGH SCHOOL WINTER FORMAL RULES

1. All rules in the SAFE SCHOOLS POLICY are in effect.
2. All guests attending the Winter Formal Dance are the responsibility of the PVHS students with whom they are attending the event. As such, violating school policy and/or Education Code may result in both students being asked to leave. The responsibility of picking up the attendees will fall upon the PVHS parent(s).
3. Doors to the formal will open at 8:00pm. Students may not enter the formal after 9:00pm.
4. Students may leave the formal at any time, but once they leave, they may not re-enter.
5. Students will be randomly breathalyzed.
6. All students will be searched being entering the dance. The following items are not acceptable and will be confiscated by security guards:
  - a. Glow in the Dark items
  - b. Gum/Open Mint Containers
  - c. Wallet chains
  - d. Markers
  - e. Pens/Pencils
  - f. Lighters/Matches
  - g. Water Bottles or Glass Bottles
  - h. Canes & Zoot Chains
  - i. Liquid Items, including bottled water and drinks
  - j. Containers with screw-on caps or lids including: Perfume/cologne bottles, eye drops, mouthwash
7. Students may receive disciplinary action if caught in possession of any of these items:
  - a. Alcohol/Flasks
  - b. Weapons
  - c. All Tobacco Products & Accessories
  - d. Any item(s) that can be used as a weapon
  - e. Sharp Objects
  - f. Any Illegal Substance
8. PARENTS or PERSON(s) listed on the emergency contact will be called to immediately transport students home if violations of the Safe School's Policy and/or Education Code occur. Violations may result in seniors not participating in end of year activities, including walking at Graduation. If the listed contacts are unavailable for pick-up, local police will be called for assistance.
